1-3 The Committee also considered the letter No. FOS/5737 dated 18th August, 1998 written by Professor A.S. Malik, Foreign Students' Advisor, regarding the cases of foreign students which were sent for approval of the Equivalence Committee in its meeting held on 12.5.1997 and in view of the discussion the matter was thoroughly debated and discussed. In view of the clarification offered by the Foreign Students' Advisor it was resolved that the cases listed in Annexure B-I and B-II on page 2 and 3 of the minutes be approved as such. However, in future the information required will be obtained by the Foreign Students' Advisor in the application form for admission of Foreign students to Delhi University.

4. Md. Rezaul Karim : B.S.S. Honours Examination from the University of Dhaka and M.S.S. Degree in Sociology from the Univ. of Dhaka, Bangladesh. M.Sc.(P) Anthropology
